Consumer Reports fuel economy ratings are derived from a series of actual road tests, including city, highway, and country-road driving. Each car is driven by at least two engineers to account for variability in driving styles. By contrast, the EPA's widely advertised mileage estimates are obtained through a laboratory test involving a machine called a dynamometer where car wheels are moved at different speeds while the car is stationary. We believe our estimates, which tend to be lower than the EPA's, more accurately reflect the fuel economy each car will get in real life.


