
■ **Continue to work with AFCEE Sustainability Team to assure cross-functional communication**


AF/A7C is using a four-phase approach to develop the web-based playbook and business process repository


A7C Playbook Deployment Approach



Successful creation of a Web-based playbooks requires coordination among functional and domain experts

Playbook Development Team Cross Functional Coordination





Process maps contain the following:

- 1 Title bar, indicating the map title and version date
- 2 Swim lanes, indicating the responsible actor for each process step
- 3 Process shapes, indicating types of actions, their titles and order number
- 4 Shape key



EMS & ESOHCAMP Playbook Goals

- Document and standardize business processes within programs
- Identify areas for improvement to *Lean* and *Streamline* standard processes
- Produce one central location for standard processes and business rules where all documentation, dashboards, and processes can be retrieved
 - Provides guidance on “how” to implement AF EMS/ESOHCAMP instruction
 - “One Stop Shop”
 - Provides Continuity
