Utility Privatization (UP)

- UP leverages private sector financing in order to modernize DoD systems at a cost lower than if the government retained ownership
- Comprised of two contractual actions:
 - Conveyance of the utility system to a private/public owned utility company
 - Utility distribution services contract for up to 50 years
- UP projects correct many environmental Notices of Violations and life safety deficiencies that may otherwise remain un-financed or subject to the availability of funds if retained under DoD ownership



Energy Savings Performance Contracts (ESPCs)

- ESPCs leverage private sector financing for installing energy efficient equipment in DoD facilities IAW 42 USC 8287 & Energy Policy Act 2005
- ESPCs help to meet the federal government's energy efficiency, water conservation, and renewable energy goals.
- Under an ESPC, contractor designs, constructs, and finances energy savings project. Agency makes payments (from appropriated funds) over life of the contract, to the contractor, from savings reduction in utility bills.
- Reduces DOD Dependency on Foreign Oil
- Added Benefit: Reduces Pollution SO₂ and NO₂

Renewable Energy Certificates (REC)

Energy Policy Act of 2005 - Title II - Renewable Energy

- Sec. 203 Federal Purchase Requirements "To the extent economically feasible and technically practicable"
 - Not less than 3% in FY07 through FY09
 - Not less than 5% in FY10 through FY12
 - Not less than 7.5% in FY13 and each year after
- The need to meet short term goals is being accomplished by the purchase of Renewable Energy Certificates (RECs) also known as Green Tags.
 - RECS are not the power itself but represent the environmental attributes of power generated by renewable sources.
 - Can be purchased and used nationally
 - Least cost current means to achieve the goals
 - DESC currently supports DoD, DOE, DOC, IRA, EPA, VA, USPS, NASA

PKI allows user access to a DOD EMALL account using a Common Access Card (CAC) or a DoD-approved PKI External Certificate Authority (ECA) digital certificate. **After enabling the PKI, the use of the user name/fifteen-character password combination is no longer required.** Users that have been issued a CAC will be required to use their CAC. Users that have not had a CAC issued will be required to obtain an ECA.

A product defined in 40 CPG, Section 247, that meets or exceeds the recommended recycled-content levels as specified by the EPA Recovered Materials Advisor Notice (RMAN) for Remanufactured Toner Cartridges. Toner cartridges are used in laser printers, photocopiers, fax machines, and microphotographic printers. When the toner cartridge is spent, it can be returned to a remanufacturer or the manufacturer to be refilled, refurbished, and cleaned for resale.
- E5 **Binders, clipboards, file folders, clip portfolios, and presentation folders**

Binders, clipboards, file folders, clip portfolios, and presentation folders are commonly used office products made from a variety of materials. A loose-leaf binder contains split metal rings attached to a metal back that hold perforated sheets of paper. Chipboard, pressboard, plastic-covered chipboard or paperboard, cloth-covered chipboard or paperboard, and solid plastic binders can all be made with recovered materials. Clipboards, file folders, clip portfolios, and presentation folders can be made of solid plastic containing recovered materials.
- E6 **Printer ribbons**

Reinked printer ribbons are used ribbons in printer cartridges that are reinked using electromagnetic machinery. Ribbons can be reinked until they reach the end of their useful life and begin to fall apart. Reloaded printer ribbons are new fabric ribbons that are reloaded into reused cartridges when used ribbons run out of ink.

Plastic trash bags, also called trash can liners, are widely available with recovered material content including HDPE, LDPE, and LLDPE. The amount of recovered materials used in the manufacturing process is affected by the color, size, and thickness of the bag."





Changes to environmental legislation have resulted in an increased emphasis on the procurement of environmentally preferred products. The GPR can be used by military services and federal agencies to track environmentally friendly purchases and provide required input to pollution prevention reports (i.e., RCRA6002). The GPR provides visibility of total green and non-green procurements from Defense Logistics Agency (DLA) and General Services Administration (GSA). Each authorized user can customize their report and can display results by Service/Agency, DODAAC (DOD Activity Address Code) and Environmental Attribute Code (ENAC).

ERLS is DLA's tool for pollution prevention and compliance reporting. ERLS captures DLA requisitions from the Enterprise Business System (EBS), Base Operations Support System (BOSS), Defense Fuel Automated Management System/Special Fuels (DFAMS/FAS) and GSA's Management Information System (MIS).
