PREFACE

Established in 1993, the U.S. Army Peacekeeping Institute was recently renamed and transformed into the U.S. Army Peacekeeping and Stability Operations Institute, part of the U.S. Army War College. This event served as the impetus for our Library reissuing its bibliography on peacekeeping. Now in the fourth revised edition, *Peacekeeping: A Selected Bibliography* generally includes books, documents, periodical articles and Internet sites dated 2000 to the present. (Each Internet address was verified on 22 April 2004.)
